3. **CalFIT Investment Vehicle** – Representatives from California Fixed Income Trust (CalFIT), a California-based Local Govt. Investment Pool (LGIP), will provide the Finance Committee with an overview of the investment pool that provides public agencies the opportunity to invest funds in rated pools that are managed in accordance with state law and GASB 79. This is an informational session.
