

CT1 Alameda Oil System and Fire Damage Refurbishment Project ("Project") Staff is seeking a recommendation for Commission approval of the Project and delegating authority to the General Manager or his designee to award bids, execute agreements, and to issue purchase orders for the Project in accordance with NCPA purchasing policies and procedures, without further approval by the Commission, for a total cost not to exceed \$3,000,000, and further authorizing use of FY 2021 CT1 Diesel Starter Modification encumbered funds in the amount of \$1,000,000 and any insurance proceeds up to \$2,000,000 for inspection, evaluation, and potential refurbishment; and should the costs exceed these amounts or insurance proceeds not be available to complete the Project, staff will bring the Project back to Facilities Committee and Commission for further discussion and potential approval. - 3. All NCPA Facilities, Members, SCPPA Electrical Maintenance Consultants, Inc. First Amendment to MTGSA Staff is seeking a recommendation for Commission approval of a First Amendment to the Multi-Task General Services Agreement with Electrical Maintenance Consultants, Inc., increasing the not to exceed amount from \$2,000,000 to \$5,000,000, with no other changes to the contract terms and conditions, for continued use at all facilities owned and/or operated by NCPA, NCPA Members, by SCPPA, and SCPPA Members. All purchase orders will be issued following NCPA procurement policies and procedures. (Commission Category: Consent; Sponsor: CTs)
