Item #1 – Opening Remarks & Introductions

NCPA Legislative and Regulatory Affairs Committee Vice Chair Mark Chandler, City of Lodi, called the meeting to order at 12:02 pm. A quorum was present. Introductions were made. Those in attendance are shown on the attached attendance list.

PUBLIC FORUM

No members of the public were present.

REPORTS/ACTION ITEMS

Item #2 Approval of Minutes

Motion: A motion was made by Jerry Serventi, City of Alameda, and seconded by James “Bo” Sheppard, City of Biggs, to approve the minutes from the December 1, 2021 regular meeting, and the minutes from the Legislative and Regulatory Affairs Committee special meeting held on February 16, 2022. *A majority carried the motion on a roll call vote. San Francisco BART, Gridley, Palo Alto, Plumas-Sierra, Port of Oakland, Shasta Lake and Truckee-Donner were absent.*

Item #3 Budget Workshop

Jane Cirrincione, AGM Legislative & Regulatory Affairs, presented background information and requested a recommendation for Commission approval of the Legislative and Regulatory Affairs FY 2023 budget. Ms. Cirrincione provided an overview of the budget planning process for the FY2023 Legislative and Regulatory Affairs Budget. She reported that the \$1.41 million operating budget includes 62% for State and Federal Advocacy, 12% for Western Programs, 15% for Customer Programs, 6% dues for key coalitions, and 5% for miscellaneous expenses. The breakdown of the \$1.41 million operating budget does not include \$510,347 in pass-through costs. Ms. Cirrincione reported that the net change in the FY2023 L&R baseline budget is \$127,325, or a 9.9% increase, over the FY2022 budget related primarily to NCPA's new Grant

Writing Assistance and Grant Tracking Services, and an increase in LCFS Support Services and State Advocacy.

Motion: A motion was made by Pat Keener, City of Redding, and seconded by Jerry Serventi, City of Alameda, recommending Commission approval of the Legislative and Regulatory Affairs programs' FY2023 proposed budget. *A majority carried the motion on a roll call vote. San Francisco BART, Gridley, Palo Alto, Plumas-Sierra, Port of Oakland, Shasta Lake and Truckee-Donner were absent.*

Item #4 Multi-Task Consulting Services Agreement with Government Affairs Consulting
Jane Cirrincione, AGM Legislative & Regulatory Affairs, presented background information and requested a recommendation for Commission approval of a Multi-Task Consulting Services Agreement with Government Affairs Consulting for state legislative consulting services which shall not exceed \$990,000 over five years for use by NCPA.

Motion: A motion was made by Kathy Watanabe, City of Santa Clara, and seconded by Cindy Sauers, City of Ukiah, recommending Commission approval authorizing the General Manager or his designee to enter into a Multi-Task Consulting Services Agreement with Government Affairs Consulting for state legislative consulting services for an amount not exceed \$990,000 over five years, for use by NCPA. *A majority carried the motion on a roll call vote. San Francisco BART, Gridley, Palo Alto, Plumas Sierra, Port of Oakland, Shasta Lake and Truckee Donner were absent.*

Item #5 Multi-Task Consulting Services Agreement with Kanner and Associates, LLC
Jane Cirrincione, AGM Legislative & Regulatory Affairs, presented background information and requested a recommendation for Commission approval of a Multi-Task Consulting Services Agreement with Kanner and Associates, LLC to provide federal legislative and regulatory advocacy, which shall not exceed \$930,000 over three years for use by NCPA.

Motion: A motion was made by Pauline Roccucci, City of Roseville, and seconded by Jenelle Osborne, City of Lompoc, recommending Commission approval authorizing the General Manager or his designee to enter into a Multi-Task Consulting Services Agreement with Kanner and Associates, LLC for federal and legislative and regulatory advocacy services for in amount not exceed \$930,000 over three years, for use by NCPA. *A majority carried the motion on a roll call vote. San Francisco BART, Gridley, Palo Alto, Plumas-Sierra, Port of Oakland, Shasta Lake and Truckee-Donner were absent.*

Item #6 Federal Affairs

Jack Lincoln, Federal Affairs and Member Programs Manager provided an overview of the political landscape in Washington, D.C., highlighting the impasse over one of President Biden's signature pieces of legislation, the Build Back Better (BBB) Act. However, he explained that the inability to pass the BBB Act has created the possibility for a standalone energy package that could include clean energy incentives—an NCPA priority issue. Mr. Lincoln outlined key energy policy efforts including: advancing tax incentives for energy storage including NCPA's hydrogen project, aligning future state/federal climate programs, efforts to advance federal hydropower relicensing, possible funding for green hydrogen development, NCPA's sediment removal project, electric vehicle charging infrastructure, and electric utility grid hardening to prevent wildfires.

Item #7 Federal Power Program

Regina Rieger, Federal Power Resources Program Manager, provided an updated on the Central Valley Project Hydropower CVP cost and resource. She reported that the third-year of drought conditions is reducing base resource availability and pushing up the effective unit rate. Ms. Rieger outlined efforts agencies are undertaking to review the CVP operations under the Endangered Species Act (BiOps), work being done by the State Water Resource Control Board to finalize Bay Delta Water Quality Control Plan (flow requirements on San Joaquin and Sacramento river systems), prospects for Bipartisan Infrastructure Bill funding, the potential for grants for updates to CVP projects, and inflation challenges.

Item #8 Customer Programs

Emily Lemei, provided an update on the implementation of new equity spending requirements for the Low Carbon Fuel Standard (LCFS) and next steps for the Advanced Clean Fleets regulation—and shared joint utility efforts to plan for and support a regional charging network. Ms. Lemei also provided an update on activities related to identifying funding opportunities, including the availability of contracts for grant writing assistance. Ms. Lemei concluded with a reminder that the annual energy efficiency report is due to the California Energy Commission by March 15.

Item #9 Regulatory Affairs

Scott Tomashefsky, NCPA's Regulatory Affairs Manager, began the update by reviewing the current status of the state's cap-and-trade program followed by an overview of key policy areas being addressed at the California Energy Commission, the California Air Resources Board, the California Public Utilities Commission, the Wildfire Safety Advisory Board, and the Federal Energy Regulatory Commission. He ended the discussion with a summary of the CPUC's most recent Net Energy Metering Proposal, as well as CAISO's recently released 20-Year Transmission Outlook.

Item # 10 State Legislative Affairs

Gregg Cook, Principal, Government Affairs Consulting, provided an update on state legislative priorities. He addressed the Governor's 2022-23 budget proposals outlined in the Blue Print for California, noting the Governor is proposing to add \$6.1 billion over five years to last year's \$3.9 billion for zero electric vehicle (ZEV) program acceleration and an additional \$2 billion to address clean energy priorities. Legislative proposals are being developed, but not yet introduced, to focus on electricity reliability and resource adequacy, transmission issues, offshore wind, electrification, and wildfire program implementation/administration.
