2. Approve Minutes from the May 3rd and May 17th Facilities Committee Meetings

3. All Generation Services Facilities – Mark III Construction, Inc. for Multi-Site Physical Security Upgrade Project – Staff is seeking a recommendation for Commission approval of a Public Works Agreement with Mark III Construction, Inc. for an amount not to exceed \$1,283,481 for physical security upgrades at the NCPA Generation Services Facilities and delegation to the NCPA General Manager authority to issue purchase orders against the agreement to carry out the work. (*Sponsor Generation Services*)

4. Hydroelectric Facility – Collierville Unit 2 Generator – Staff is seeking a recommendation for Commission approval delegating authority to the General Manager to enter into one or more agreements for a total not-to-exceed amount of \$1,000,000 for the repair and/or replacement of the Collierville Unit 2 Generator. (*Sponsor Hydro*)

5. All Generation Services Facilities, Members, SCPA – RADCO Communications LLC – Staff is seeking a recommendation for Commission approval of a five year Multi-Task General Services Agreement for communication system maintenance services including tower and passive repeater maintenance for an amount not to exceed \$1,000,000 at all facilities owned and/or operated by NCPA, its Members, SCPA, and SCPA Members. All purchase orders issued pursuant to the agreement will be charged against approved Annual Operating budgets. (*Sponsor Hydro*)

6. **All Generation Services Facilities, Members, SCPPA – Stantec Consulting Services, Inc. –** Staff is seeking a recommendation for Commission approval of a five year Multi-Task Consulting Services Agreement for engineering consulting services for an amount not to exceed \$1,000,000 at all facilities owned and/or operated by NCPA, its Members, SCPPA, and SCPPA Members. All purchase orders issued pursuant to the agreement will be charged against approved Annual Operating budgets. (*Sponsor Hydro*)
7. **All Generation Services Facilities, Members, SCPPA – DRS Marine, Inc. –** Staff is seeking a recommendation for Commission approval for a five year Multi-Task General Services Agreement for underwater and confined space entry maintenance services for an amount not to exceed \$1,000,000 at all facilities owned and/or operated by NCPA, its Members, SCPPA, and SCPPA Members. All purchase orders issued pursuant to the agreement will be charged against approved Annual Operating budgets. (*Sponsor Hydro*)
8. **All Generation Services Facilities, Members, SCPPA – Global Diving and Salvage, Inc. –** Staff is seeking a recommendation for Commission approval for a five year Multi-Task General Services Agreement for underwater and confined space entry maintenance services for an amount not to exceed \$1,000,000 at all facilities owned and/or operated by NCPA, its Members, SCPPA, and SCPPA Members. All purchase orders issued pursuant to the agreement will be charged against approved Annual Operating budgets. (*Sponsor Hydro*)
9. **All Generation Services Facilities – Univar USA, Inc. First Amendment –** Staff is seeking a recommendation for Commission approval of a First Amendment to the existing five year Multi-Task Equipment, Materials, and Supplies Agreement for purchase and delivery of chemicals, adding chemicals to the purchase list and increasing the not-to-exceed amount from \$250,000 to \$1,200,000 for use at all facilities owned and/or operated by NCPA. All purchase orders issued pursuant to the agreement will be charged against approved Annual Operating budgets. (*Sponsor Geo*)
10. **Geothermal Facility – Brian Davis dba Northern Industrial Construction Public Works Agreement -** Staff is seeking a recommendation for Commission approval authorizing the General Manager to enter into a Public Works agreement with Brian Davis dba Northern Industrial Construction for a not-to-exceed amount of \$731,944 for the Sulfur Platform Project at the Geothermal Plant 2 Facility and delegation to the NCPA General Manager authority to issue purchase orders against the agreement to carry out the work. (*Sponsor Geo*)
11. **CAISO Overgeneration Update (Informational Only) –** Staff will provide a summary of how often and when Overgeneration notifications have been sent out, as well as highlight the main points of the Overgeneration procedure (including an example of an Overgeneration notification). (*Sponsor Power Management*)
