2. Review of the June 30, 2022 Draft Audited Financial Statements and Related Reports Representatives from the auditing firm Baker Tilly US, LLP will present the June 30, 2022 draft audited financial statements and related reports. Staff is recommending that the Finance Committee recommend Commission acceptance of the June 30, 2022 audited financial statements and related reports with any non-substantial changes. Staff is also recommending the Committee acknowledge and authorize the inclusion of Regulatory Accounting in the June 30, 2022 audited financial statements to include the following: 1) net change in swaps valuation; 2) swap termination fee; 3) accrued payroll and benefits; net pension and OPEB liabilities; 4) difference between annual depreciation/amoritization and debt service payments; 5) prepaid costs; 6) MID construction advance; 7) inventory purchases; and 8) Asset Retirement Obligations and related participant collections.

3. Annual Review of the NCPA Employee Pension and OPEB Programs Staff will provide the annual update on the OPEB and Pension funding statuses in accordance with the Agency's Long-Term Funding Plans.
