## **REPORTS AND COMMITTEE ACTION ITEMS**

2. **California CLASS Investment Vehicle** – Representatives from CLASS will provide the Finance Committee with an overview of the investment pool that provides public agencies the opportunity to invest funds in rated pools that are managed in accordance with state law. This is an informational session.
3. **Review of the June 30, 2023 Draft Audited Financial Statements and Related Reports**  
Representatives from the auditing firm Baker Tilly US, LLP will present the June 30, 2023 draft audited financial statements and related reports. Staff is seeking a recommendation from the Finance Committee that the Commission accept and file the June 30, 2023 audited financial statements and related reports with any non-substantial changes. Staff is also recommending the Committee acknowledge and authorize the inclusion of Regulatory Accounting in the June 30, 2023 audited financial statements to include the following: 1) accrued payroll and benefits; net pension and OPEB liabilities; 2) difference between annual depreciation/amortization and debt service payments; 3) prepaid costs; 4) MID construction advance; 5) inventory purchases; and 6) Asset Retirement Obligations and related participant collections.
4. **Appointment to the NCPA Finance Committee** – Recommend appointing Katie Edgar, Finance Director for the City of Healdsburg, as a member of the NCPA Finance Committee.
5. **Accept the 2024 Finance Committee Meeting Calendar** – Staff will present and seek acceptance of the 2024 Finance Committee meeting calendar.

6. **Annual Review of the NCPA Employee Pension and OPEB Programs**  
Staff will provide the annual update on the OPEB and Pension funding statuses in accordance with the Agency's Long-Term Funding Plans.
