Subject: October 26, 2017, Executive Committee Meeting Minutes

1. **Call to Order** – The meeting was called to order by Chair Bob Lingl at 8:00 am, at NCPA's Roseville Office, 651 Commerce Drive, Roseville, California.

2. **Approval of Minutes** – approval of the minutes from the August 24, 2017, Executive Committee meeting were approved. (Motion by Teresa O'Neill and second by Roger Frith). Motion passed by unanimous voice vote. Mark Chandler and Greg Scharff were absent.

  - NCPA's bond legal counsel has announced his retirement. NCPA currently contracts with Orrick Herrington & Suttcliffe for bond legal services. NCPA does plan refunding bonds in the spring of 2018, which does require specialty work of legal counsel. The Committee discussed and agreed that conducting and Request for Proposal of special bond counsel is needed.

Gave an update on the CVPIA litigation. Discovery of documents are due on October 30.
 NCPA staff James Takehara will be the trial witness representing NCPA. Case General Counsel spoke with their staff and have agreed to the terms of the proposed agreement.
