Item #1 - Opening Remarks & Introductions

NCPA Legislative and Regulatory Affairs Committee Chair Mark Chandler, City of Lodi, called the special meeting to order at 9:00 am. Introductions were made. Those in attendance are shown on the attached attendance list.

PUBLIC FORUM

No members of the public were present.

REPORTS/ACTION ITEMS

Item #2 Insights on the Forces Shaping Today's Electricity Industry and Energy Policy Jan Smutny-Jones, Chief Executive Officer of the California Independent Energy Producers Association, discussed several of the key drivers of policy and the industry in California today, including the impacts of the drought on hydropower production and its implications for reliability and affordability, and emerging technologies including hydrogen, off-shore wind, and pumped storage. Mr. Smutny-Jones responded to NCPA Legislative and Regulatory Affairs Committee Members' inquiries related to: Affordability, renewable hydrogen as a strategy for decarbonization, climate impacts on energy section, procurement mandates, regionalization, federal legislative issues, and insights on past and future of energy policy.

Item #3 – Approval of NCPA L&R Committee Meeting Minutes from April 28, 2021 Regular Meeting, and May 3, 2021 and May 17, 2021 Special Meetings.

Motion: A motion was made by Jenelle Osborne, City of Lompoc, seconded by Sudhanshu Jain, City of Santa Clara, to approve the minutes from the April 28, 2021 Legislative & Regulatory Affairs Committee Meeting, and Minutes from L&R Committee Special Meetings held on May 3, 2021 and May 17, 2021. A majority carried the motion on a roll call vote. San Francisco BART, Plumas-Sierra, Lake Shasta and Ukiah were absent.

Item #4 – Multi-Task Consulting Services Agreement with Central Coast Energy Services, Inc. Emily Lemei, Customer Programs Manager & Regulatory Affairs, presented background information and requested a Committee recommendation for Commission approval of a five-year Multi-Task Consulting Services Agreement with Central Coast Energy Services, Inc for income verification services, with a not to exceed amount of \$1,000,000, for use by NCPA, NCPA Members, SCPPA, and SCPPA Members. Work completed by this consultant will be processed and billed to the individual utility system as a pass-through charge under NCPA's Support Services Agreement.

Motion: A motion was made by Sudhanshu Jain, City of Santa Clara, and seconded by Jerry Serventi, City of Alameda, recommending Commission approval authorizing the General Manager or his designee to enter into a five-year Multi-Task Consulting Services Agreement with Central Coast Energy Services, Inc., with a not to exceed amount of \$1,000,000, with any non-substantial changes recommended and approved by the NCPA General Counsel, for use by NCPA, NCPA Members, SCPPA, or SCPPA Members. *A majority carried the motion on a roll call vote. San Francisco BART, Plumas-Sierra, Shasta Lake and Ukiah were absent.*


