MONTHLY REPORTS

4. Operational Report

Ryan Johnson presented the Operational Report for April. There were no OSHA recordable incidents. There were two *near-miss* incidents.

- An operator discovered a temporary fitting placed on a sulfuric acid feed line used for purging the system was not removed and replaced with a fitting necessary for regular service. Staff has been instructed to document temporary changes in the LOTOT system to ensure proper removal of temporary fittings before lifting the LOTOT. There were no injuries or equipment damaged from this incident.
- 2. A contractor's employee smelled strongly of marijuana. When questioned the employee admitted to smoking marijuana during his lunch break. The contractor submitted their employees to drug testing and the offending employee was not allowed back on NCPA property. There were no injuries or equipment damaged from this incident.

There were no NERC/WECC or permit violations. LEC was in its annual outage for the month of April. Next annual outage is scheduled for April 2025.

The operational report reflected monthly production of 1,608 MWH, 14 service hours, and equivalent operating availability of 0.0%. The report set for the Capacity Factor @ 302MW Pmax of 0.7%. There was one cold start, one warm start and no hot starts during the month.

5. Market Data Report

6. Monthly Asset Report

Rafael Santana presented the monthly asset report for March 2024, showing that net costs are over budget. Rafael reviewed the monthly historical comparisons as well as the 12-month history, showing March had a soft market.
