MONTHLY REPORTS

4. Operational Reports for April 2023

Ryan Johnson presented the Operational Report for April 2023. There were no OSHA recordable accidents, no NERC/WECC or permit violations, and no forced outages. There will be an outage in May/June 2023 for inspection of the new gearbox, as required per the warranty. The outage will last approximately 5 days, and the exact dates are still TBD. On Tues, May 9, there will be an outage to allow Siemens to inspect a gas leak in the combustion turbine.

The operational report reflected monthly production of 41 MWH (approximately 15 minutes) which took place during the plant shut down to go into the annual outage. There were no other operating statistics in the month of April due to the outage.

5. Monthly Asset Report

Rafael Santana presented the monthly asset report for March 2023. Rafael reviewed monthly budget numbers for the project. Rafael reviewed the monthly historical comparisons as well as the 12-month history. He reported that March was a very good month, with the highest margins for that month in the history of the plant. It was noted that there was an error with the chart on the cumulative net cost slide (last slide of the presentation). Rafael said he would correct the error and distribute an updated slide to attendees once the meeting was over.

12. Additional Operational Updates

Rafael updated the committee on the gearbox replacement. The new gearbox has been installed and all restrictions removed. The highest production since the replacement was 200 MW. NCPA submitted data to Seimens after that run, and no vibration was found. NCPA will continue to monitor and send data to Seimens as needed. Staff is ordering a root cause analysis of the HP exhaust due to finding broken parts, to determine what may be causing these parts to fail so frequently.
