4. Operational Reports for {Month Year}

Energy prices were down 11% and fuel prices were down 19%, which contributed to the higher revenues. Mike reviewed the monthly historical comparisons as well as the 12-month history.

INFORMATIONAL ITEMS

14. Gas/Renewable Energy Supply Agreement Opportunity

Representatives from RBC Capital Markets presented a proposal on a PPA structured opportunity for a natural gas prepay transaction contract (Minnesota Municipal Gas Agency, or MMGA). Background on the formation of MMGA was presented to the Committee, including key provisions. Current MMGA participants have a heavy load in winter, and RBC is now looking to expand to select agencies who might benefit from offset of summer loads.

RBC reviewed terms and mechanics of the energy prepayment transaction. The potential benefits of participating in MMGA's transaction/energy supply contract were also reviewed, along with historical trends surrounding these types of transactions.
