# 6. Legal Committee Meeting During NCPA Annual Conference

Jane Luckhardt previewed the Committee about the discussion she is planning during the Legal Committee meeting at NCPA's Annual Conference on October 4 in Monterey. Since Barry DeWalt has announced his retirement and the October 4<sup>th</sup> meeting will be his last, the gavel will pass to the new chair. Matthew Slentz of Colantuono, Highsmith & Whatley will be speaking on rate issues and restrictions on public utility rates. He will discuss permissible rate structures, income graduated fixed charges, and general fund transfers. Randy Howard commented about not only the legal issues but how the impacts and capabilities of technology itself affects what we can do. Rachel Sommovilla requested that in addition to residential, the presentation also include the industrial and commercial rates. The committee had a robust discussion.

# 7. Legal Committee Charter

Jane Luckhardt presented a starting point for a Charter for the Legal Committee to identify its purpose, structure and operations, and information about its meetings. The committee liked the idea of adopting a Charter. Staff will send the draft to the Committee members for input and the item will be on the next meeting to consider for adoption. The Committee requested staff include the subject matter jurisdiction of the Legal Committee.

# 8. General Counsel Updates

Jane Luckhardt said NCPA has a great slate of speakers planned for the Annual Conference. Randy Howard said Dan Hartman of PFM Financial will discuss direct pay, renewable projects going forward, and insight out of Washington, D.C. The Chairman of the Board of NERC will speak on reliability of the grid and NERC's concerns as to the pace of change, along with other excellent panel discussions and keynote speakers.

#### **NORTHERN CALIFORNIA POWER AGENCY**

#### LEGAL COMMITTEE CHARTER

#### **PURPOSE**

The Amended and Restated Rules of Procedure for the Commission of the Northern California Power Agency (NCPA), also known as the NCPA Bylaws, created the Legal Committee. The purpose of the Legal Committee is to consider and report on such legal matters as are referred to it by the Commission, the Executive Committee, the General Manager, or the General Counsel.

#### **STRUCTURE AND OPERATIONS**

The Legal Committee shall consist of the principal attorney for each NCPA Member (City Attorney or General Counsel), or his or her designee. Each committee member may also designate an alternate representative(s) to serve on the Legal Committee. Each NCPA Member of the Committee shall be entitled to cast one vote.

The Legal Committee is a standing, advisory committee, and is subject to the Brown Act.

The Legal Committee shall elect its Chair and Vice Chair at an annual meeting, or at a regular meeting if a vacancy occurs. The terms of office for the Chair and Vice Chair shall be indefinite terms and such service shall be at the pleasure of the Legal Committee. NCPA General Counsel will appoint staff to record minutes of the meetings.

#### **MEETINGS**

<u>Frequency.</u> The Legal Committee shall regularly meet at least four times each year, or more frequently as circumstances dictate. Each year, the Legal Committee will consider and approve the regular meeting dates for the following calendar year. The Legal Committee's annual meeting shall occur during NCPA's Annual Conference that typically takes place in September or October.

<u>Conduct</u>. The Chair will lead all meetings, and if the Chair is unable to attend, the Vice Chair will serve as the alternate Chair. If both the Chair and Vice Chair are unavailable, a member of the committee may serve as an alternate Chair.

A quorum is required for the Legal Committee to conduct Agency business and shall consist of those principal attorneys for each NCPA Member, or their designated representatives or alternate representatives, representing a numerical majority of the NCPA Members. The Committee may act on any items listed on an Agenda regardless of whether the matters appears or is described as an Action Item, a Report, a Discussion Item, or an Information Item.

#### **JURISDICTION**

The Legal Committee shall consider and report on legal matters within the purview of NCPA as established by the Amended and Restated Joint Powers Agreement, and in support of NCPA's mission to provide cost effective wholesale power leading to a reliable and resilient carbon neutral supply, ratepayer focused power management, sustainable generating assets, energy-related services, and advocacy on behalf of public power consumers through joint action.
