#### 1. Call Meeting to Order and Roll Call

The special meeting was called to order at 8:33 a.m. by Chair Barry DeWalt. At roll call the following members were present by telephone:

A quorum was present. Subsequent to roll call, Gridley-Anthony Galyean and Santa Clara-Brian Doyle joined the meeting.

#### 2. Public Comment

The Chair read the notification regarding Public Comment and asked if any member of the public would like to address the Committee. There was no public comment.

#### 4. Closed Session

At 8:40 a.m. the Committee convened to closed session. The Legal Committee returned to open session at 8:55 a.m.

#### 5. Report from Closed Session

General Counsel Jane Luckhardt reported that no reportable action was taken during closed session.

#### 6. Discussion Regarding Procurement

Jane Luckhardt discussed with the Committee the development of a Power Purchase Agreement (PPA) with South Feather Water and Power Agency. She said the agreement is patterned after the PPA for the Antelope Solar project. She noted NCPA has previously worked with South Feather Water and Power. Through the agreement, NCPA would purchase certain energy, capacity rights and other attributes from four existing hydroelectric generating plants. NCPA views this as a great opportunity as it would be able to operate similar to how we operate Collierville and be able to shape the energy. Santa Clara commented that it is definitely interested in the project and will take all or part of the project depending on the interest of others. Jane Luckhardt inquired whether the entire

Committee would like to review the contract going forward, or review by a smaller group. Tony Galyean will ask about his client's interest, but would be willing to participate in a deeper review of the contract. Amy Bartell also offered her assistance. Barry DeWalt said he is happy to work on review of the agreement. NCPA's Tony Zimmer has already started working with Santa Clara. The draft sent to the Committee for review does not include the confidential pricing information. NCPA has sent a term sheet South Feather Water and Power, and expects a response soon. Jane Luckhardt will send the term sheet information to the Committee via a confidential communication when it becomes available.

#### 7. General Counsel Updates

A new General Manager was just named by Truckee Donner, Rem Scherzinger who formerly was at the Nevada Irrigation District. Jane Luckhardt said she is watching for further changes to the Brown Act coming from Executive Orders. Brian Doyle commented he would love to see some of the changes become permanent; many indicated agreement with that sentiment. Janice Magdich asked about the status of NCPA's facilities in Lodi. Jane said the new turbine at LEC was installed and the unit was available June 30, so all Resource Adequacy is available. The STIG is also now back in operation and available. The work environment for both projects was great throughout the COVID-19 issues and all staff and contractors remained healthy.

Randy Howard commented that the Geothermal facility is also back in operation. He told the group about a new project led by CTs plant manager Mike DeBortoli. Mike has started looking at hydrogen as a supplemental fuel source for the LEC plant to reduce emissions. There will be more information to come about this project.

Randy also reported NCPA experienced its first wildfire concern last week within a few miles of Collierville. The fire was extinguished very soon. He said it is unusual for a fire in that vicinity, and especially so early in the year. He said the Hydro facility has undertaken a project starting in July to replace all insulators on the Collierville – Bellota 230 kV line. They will deenergize and complete the work on one side at a time. It is a great opportunity to double and triple check those lines.

## **Strategic Initiatives**


- Attract; develop and retain professional, diverse, high quality staff and governance

- Communicate; articulate and promote the value of NCPA and public power utilities to member communities and others





# **Project Debt Rolling Off**

- Geo
  - Final maturity on 7/1/2024
  - Consider changes to the structure prior to adding technology such as battery storage
- Hydro
  - 2024 three series of Hydro bonds are paid off
  - 2032 remaining bonds paid off
  - Original plan was to finance relicensing with bond reduction from 2025 to 2032
- STIG
  - Final maturity on 8/1/2024
  - Discussion with project participants planned on the next life of the project
- \*LEC has debt through 2032

# NCPA JPA Powers - Article 1 Purpose

- Establish NCPA "for and with the purpose of:
  - Acquiring and disposing of ownership and use of revenue producing facilities, including electric generating and transmitting facilities, and
  - making more efficient use of the common powers of individual parties composing NCPA to acquire, purchase, generate, transmit, distribute, sell, interchange, and pool electric energy and capacity, and



# NCPA JPA Powers Article 1 Purpose (cont.)

 with the further purpose to develop all other reasonably necessary or appropriate powers to provide greater individual and group efficiency through the coordination indicated in this Agreement to the extent permitted by the laws and regulations governing such operations.



## **NCPA JPA Article III Powers and Functions**

- . . . Generally do any and all things necessary or convenient to provide adequate supplies of firm and reliable power to its members.
  - Acquire and dispose of property
  - Issue bonds
  - Obtain permits, licenses, opinions and rulings
  - Form and administer nonprofit corporations
  - Perform its duties in the same manner as a general law city
  - NCPA holds all of the debts, liabilities and duties

Review and update associate membership (AM) policy, guidelines and criteria for AMs as a step to membership

- What does the JPA allow?
- Should NCPA reinitiate recruiting associate members?
- If so, what types of members would strengthen NCPA and support current member goals?
- What types of members would increase NCPA's ability to influence CAISO, and NCPA's ability to influence policies, laws and regulations?



## **JPA Associate Member Rights & Limitations**

- AMs can have non-voting representative on the Commission (A.II¶7)
- NCPA Projects or Programs allow for AM and participant voting privileges (A.II¶8.b)
- Receive assignments of WAPA energy (A.III¶1.v)
- Members any preference power purchaser or potential preference power purchaser of WAPA energy and public agency (A.IV¶1, Gov. Code 6500)
- AM pay costs of NCPA's operations as established in the AM agreement including costs (A.IV¶7)



## **Associate Members, Participants and Customers**

- Plumas-Sierra REC is an AM and an active participant in many NCPA projects
- LEC structure includes nonmember participants
- NCPA customers such as MeID and SJCE currently take Power Management services from NCPA but have no other participation within NCPA
- Traditionally, NCPA used the AM slot to give potential new members a chance to fully understand NCPA (abused in the past)
